**Credit Union 24 Board Appoints Alliant Credit Union's David Mooney as Director**

Prior to being appointed to the top leadership position at Alliant Credit Union in May 2003, Mr. Mooney held a number of executive-level and management positions at J.P. Morgan Chase & Co. and its predecessors, Chase Manhattan Bank and Chemical Bank.

Mr. Mooney has been an invited speaker at financial services conferences, and has written articles appearing in *bankstocks.com*, *Banking Strategies* magazine and *The Houston Chronicle*. He holds a B.A. in Economics from Boston College and serves on the Boards of Directors of the Illinois Credit Union Foundation, Members Development Company, Operation Hope, Inc. and the National Association on Drug Abuse Problems, as well as the Filene Research Council. He chairs the Supervisory Committee of Members United Corporate Federal Credit Union, and serves on the NASCUS Legislative Affairs Committee.
