**CREDIT UNION 24 WELCOMES 15 NEW PARTICIPANTS DURING
THE FIRST QUARTER OF 2008**

Tallahassee, Fla. — May 9, 2008 — Credit Union 24, the only national credit union-owned point-of-sale (POS) network and the largest surcharge-free ATM presence in the U.S., announced today that 15 credit unions joined the cooperative during the first quarter of 2008.
