Credit Union 24 Announces 21 Long-term Contract Renewals in Q4 2009

TALLAHASSEE, Fla. – January 20, 2010 – Credit Union 24, the country’s largest credit union-owned ATM and point-of-sale (POS) network, announced today that 21 credit unions renewed long-term contracts with the network in Q4 2009, representing more than \$2.8 billion in assets with more than 300,000 members.

“Closing the year with 21 contract renewals is a positive compliment to the eight (8) new credit unions that also joined the network in Q4 2009, as it directly reflects our dedication to the success of our participants in helping serve their members,” said Jim Park, president and CEO of Credit Union 24. “Consumers are looking for added value, convenience, and exceptional financial products and services in this current economic climate, and we’ve worked hard to help ensure our participating credit unions are positioned to provide these benefits to current and potential members. We are an extension of our participants’ employee teams, and we work with them to develop customized products and services to help ensure their long-term success.”

A total of 73 credit unions renewed contracts with the network during 2009, representing more than \$12.5 billion in assets and more than 1.3 million credit union members. Those 73 renewing credit unions have relationships with Credit Union 24 that extend as far back as 1984 and route more than 31.3 million transactions annually through the Credit Union 24 network.
