Credit Union 24 Announces 23 Long-term Contract Renewals For Q3 2009

TALLAHASSEE, Fla. – October 26, 2009 – Credit Union 24, the country’s largest credit union-owned ATM and point-of-sale (POS) network, announced today that 23 credit unions, representing more than \$2.4 billion in assets with more than 339,000 members, have renewed contracts with the network during Q3 2009.

A total of 52 credit unions have renewed to date in 2009, with 37 new credit unions joining the network during that same time period. These 89 credit unions have more than \$13.6 billion in assets with more than one (1.6) million members, and represent 22 different states around the nation with significant presence in the Northwest, Midwest and Northeast regions.

“While credit unions continue to seek out viable EFT service providers to increase their bottom line and provide value to their members, credit unions are also seeking added-value in this economy,” said Jim Park, president and CEO of Credit Union 24. “Participant ownership and exceptional relationship management are just two areas that Credit Union 24 offers that added value, and delivers it in the manner that credit unions need it most: through personalization and customization of services.”

With relationships that extend as far back as 1984 – more than 25 years – the 23 renewing credit unions’ collective membership perform more than five (5.8) million transactions annually through the Credit Union 24 network. All 52 YTD renewing credit unions conduct more than 26.5 million transactions through the credit union-owned network annually.
