Three Credit Unions Join Credit Union 24 Network in Q2 2010, Nine Credit Unions Renew Long-Term Contracts

TALLAHASSEE, Fla. — July 13, 2010 — Credit Union 24, the country's largest credit union-owned ATM and point-of-sale network, announced today that three credit unions have joined the network in Q2 2010, representing more than \$84 million in assets and more than 10,000 members. Seven credit unions have also renewed long-term contracts with the network during the same time period, representing more than \$541 million in assets and more than 108,000 members.

"We began 2010 with successful growth and retention within the network, and this quarter's addition of three new credit unions and nine renewals is a solid continuation of that progress considering the currently volatile financial environment," said Jim Park, president and CEO of Credit Union 24. "This growth illustrates our commitment to helping our participants serve their members by implementing new products and services that meet their individual needs, including PIN-less bill pay and other online banking enhancements. Credit Union 24 participants also receive competitive interchange income and offer their members with the nation's largest surcharge-free ATM access. Both of these services, among others, enhance credit unions' bottom-line and their relationships with members."

The three new credit unions to join the Credit Union 24 network include:
