In 2001, a community charter was approved for Mosaic FCU, expanding its field of membership to anyone who lives, works, worships or attends school in Harrisonburg.

"Our partnership with Mosaic FCU is a great example of how the credit union model benefits consumers at the local and national level," said Jim Park, president and CEO of Credit Union 24. "The Harrisonburg community can now benefit from the nationwide fee-free ATMs and point-of-sale access locally or while traveling near or far, for work or for pleasure.
